To acknowledge the planning application for a kiosk that will monitor the activities of the Sewage Treatment Plant just north of our Village, on the footpath between Walton and Burton. The main conclusion of the planning report from Fisher, who are supporting the application is that the design is in line with all necessary policy including ecological considerations (animals etc) and it will further reduce the egress of Phosphorus into the Walton Brook. Local Impact: no odour, minimised impact on wildlife during build and afterwards, suggested limitations on night-time working on the site and after it is finalized there should be minimum noise from the installation. It is most easily approached from Burton not Walton therefore unlikely to cause road closure within Walton.

Note the Parish Council did not raise an Extraordinary Planning Meeting to consider this as it is an improvement on an already existing infrastructure.
